

Scholarship Application Certified in Volunteer Administration (CVA) Certified Administrator of Volunteer Services (CAVS)

Application Submission Time Frame (February 15, 2021 - March 15, 2021)

DOVIA Memphis will provide <u>3</u> scholarships for \$350 for members to register for the CVA/CAVS exam. The scholarship would cover one exam and must be taken within a twelve-month timeframe. Once awarded, each scholarship recipient is responsible for all supplemental study materials and testing logistics/ requirements

Each scholarship recipient will be expected to contribute to DOVIA Memphis. Once awarded, scholarship recipients agree to:

- Present as the featured speaker at one of the bi-monthly DOVIA Memphis meetings.
- Chair next year's scholarship selection committee.
- Facilitate next year's CAVS/CVA study group.

To apply, you must be an **ACTIVE** and **PAID** member of DOVIA Memphis. All applications must be submitted via email at pcox@ncclife.org.

The deadline for receipt of scholarship applications is Monday, March 15, 2021. If you are the scholarship recipient, you will be notified no later than **April 8, 2021**. As a reminder, scholarship recipients are not eligible to reapply for a period of four years.
